## Why create an Urban Development Framework?

- An expectation that the NZTA will contribute to the Government's *Urban Growth Agenda*, as part of partnering & collaborating with others to achieve 'all-of-government' objectives
- Familiar, but relatively new area for the NZTA
- A process for developing an internal understanding of our role, before we talk more widely with others







## Policy drivers for an NZTA framework

- GPS 2018
- Minister's expectations
- Government's Urban Growth Agenda & housing affordability objective
- LTMA defines NZTA's role in transport planning, investment & regulation









## Wider national & sector context for an NZTA framework

- Funding, particularly challenges at a local level
- Poor urban form & outcomes in some places
- Technology, new & changing rapidly
- Climate change mitigation & adaptation (resilience)
- Health & safety
- Demographic change





## **Objectives of an Urban Development Framework**

The NZTA's objectives with developing a framework are:

- A clear & consistent understanding of NZTA's role
- Land use, growth management & transportation planning that is integrated
- Liveability & safety in urban areas is increased, including enabling efficient & safe access to housing







# NZTA's suggested overall approach & role in urban development

The Transport Agency will work with its partners to deliver integrated transport & land use planning, in a way that facilitates liveable urban areas, to give effect to the Government's Urban Growth Agenda & the Government Policy Statement on Transport.

Liveable urban areas will be safe and secure, have affordable & varied housing, & have accessible employment, recreation & transport options to meet the needs of a diverse population, along with supportive community facilities & services.

#### NZTA is involved already, but can increase its roles as:

- COLLABORATOR partnerships with other government agencies & local government
- INFLUENCER / SHAPER contributing to spatial planning exercises
- CO-INVESTOR in joint transport & urban development projects
- **IMPLEMENTOR** of some decisions
